Dear Parents and Guardians

Greetings from Rishikul Sanatan College.

Parents and Guardians please take note of the important reminder in regards to **Inflation Mitigation Assistance for children.**

A. Eligibility and Criteria

1. Families earning less than \$50,000 in combined annual household income will receive \$180 per child over a 6 month period.
2. Students in year 13 and below who are currently receiving subsidized transportation assistance can fill out a simple manual form that calls for details for MPAISA/MYCASH account details to receive assistance.
3. Families earning below \$50,000 annually whose children do not receive transport assistance can apply through the same manual application or online through the Inflation Mitigation Application System. <https://assistance.digitalfiji.gov.fj>
4. Those parents who do wish to apply manually can apply online. The online application will open from 19th August.
5. Those parents whose children are not receiving transport assistance need to fill in **Section D** of the application form for income verification by one of the third parties listed in Section D.
6. The application form will gather parent's details and phone number for payment. Correct parents details must be written in the form.
7. The phone number detail given must have **MPAISA/MYCASH account** as students will receive payment through this. Only one (1) phone number must be given.
8. All information given by parents must be properly verified and declared as true prior to submitting the forms back to the school.

9. All data will be verified by the school (Name of parent, Phone contact and Section D of income verification) before the details are entered on FEMIS.
10. Head of school will only update data on FEMIS once all details provided on the form meets the requirements.

B. Timeline and Deadlines

11. The forms will be available from the school office from 15th August. Filled forms must be returned to the school office.
12. All applications close on 30th September 2022 and final payment will be done on 31st October 2022.
13. The Ministry of Education will submit application data as follows for processing:

First Batch – 26th August

Second Batch – 9th September

Third Batch – 15th September

Final Batch – 30th September

14. Applications received by Ministry of Economy on 26th August will be paid out by 1st September 2022. Forms received by 9th September will be paid by 15th September 2022. Remaining will be paid by 30th September 2022 and the remaining applications will be paid by 31st October 2022.
